### 30 Killed By Tidal Wave In Pasni

QUETTA, Nov. 30.—Reports of earthquake shocks have been received from Musakhel, 90 miles from Loralai and Pasni, a port on the Makran coast. A message from Musakhel says that severe earthquake shock was felt at Port Loralai agency on the night between November 27 and 28. It caused damage in Barkhan tehsil where Pakhani levy port rest-house was rendered completely unfit for use. One villager is reported to have been killed.

Between Ranjani and Chapper ports few more persons were injured. More details are awaited.

# MUSLIM STUDENT'S "NO" TO JAI HIND

NEW DELHI, Nov. 30.—An interesting incident developed here yesterday at the Harcourt Butter High School, when a young Muslim student of about 14 years of age defied the orders of his class teacher to say "Jai Hind" instead of the usual "Yes, Sir" at the time of the roll call. Standing erect when his name was called, the young student promptly asserted, "No, Sir, this is not my slogan. My slogan is Pakistan Zindabad."

Despite the repeated warnings of his teacher, the student remained adamant and ultimately walked out of the class in protest and was duly followed by his other Muslim classmates. The altimation getting sprious, the teacher had to give in and the usual "Yes, Sir" survived the incident.—O.P.

Pasni says: "According to reports received from Makran severe earthquake shocks were feit at Pasni at 3-30 a.m. on November 28. A tidalwave followed which did much damage to buildings and merchandise. About 30 casualties are reported.

Information received from Karachi shows that wireless communication both at Pasni and Ovinara were interrupted.

## LEGAL AID TO MALAYA

NEW DELHI, Nov. 30.—A deputation of the Malaya and I.N.A. Defence Committee of South India, which met Dr. N. B. Khare, Commonwealth Relations Member, Government of India, on Tuesday and Wednesday, has presented him a memorandum urging the Government of India to exert pressure on the Malayan administration to withdraw prosecutions against Indian nationals in Malaya.

The memorandum also requested the Government to grant facilities to members of the defence committee to proceed to Malaya and Singapore to render legal aid to Indian prisoners and demanded the postponement of trials until adequate defence was made available to the prisoners. The memorandum suggested to the Government to send a deputation of lawyers to Malaya and Singapore to investigate the conditions obtaining there at

Dr. Khare told the deputation that the Government were awaiting the report of their Agent in Malaya and would take measures as suggested in the report. He assured them that the Government would avail of their offer for legal assistance if there was any need for it.
